

RESOLUTION

**TOWNSHIP OF FRANKLIN
AUTHORIZING THE TAX COLLECTOR AND TREASURER TO CANCEL
TOWNSHIP LIENS**

R -96-2015

WHEREAS, the Tax Collector of the Township of Franklin, County of Gloucester, State of New Jersey has notified the Township Committee that the following properties have two open Municipal Liens in error on each parcel located within the Township of Franklin; and

WHEREAS, when there is a prior, existing Municipal Lien on an account all future delinquent taxes should transfer automatically to the existing Municipal Lien in order that there be only one open Municipal Lien on each parcel; and

WHEREAS, Township of Franklin already being the holder of the existing Municipal Lien on these parcels and the second Municipal Lien being placed on the properties in error when the delinquent taxes weren't transferred over to the existing Municipal Lien prior to the last tax sale on December 17, 2014;

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the existing, 2014 Municipal Liens on each of the following parcels be cancelled and the open, delinquent taxes under those liens be transferred to the existing prior Municipal Liens;
