**RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE THE NEW
JERSEY DEPARTMENT OF TRANSPORTATION FY2016 MUNICIPAL AID
APPLICATION FOR SERVICES ASSOCIATED WITH THE DUTCH MILL
ROAD IMPROVEMENTS PROJECT**

WHEREAS, the Township of Franklin is desirous of requesting funding consideration from the State of New Jersey Department of Transportation (hereinafter "NJDOT") under the Transportation Trust Fund (FY2016 Municipal Aid Application) for the Dutch Mill Road Improvements Project within the Township of Franklin; and

WHEREAS, the NJDOT Transportation Trust Fund (FY2016 Municipal Aid Application) has made available to the Township of Franklin funding in order to move forward with the project entitled, Dutch Mill Road Improvements Project; and

WHEREAS, the Township Engineer has been authorized to prepare the required application and agreement known as Form SA-96; and

WHEREAS, in furtherance of same, it is necessary for the Township Committee of the Township of Franklin to authorize the Mayor to execute said application agreement to allow the Township to be eligible for the NJDOT Transportation Trust Fund (FY2016 Municipal Aid Application) for the Dutch Mill Road Improvements Project; and

WHEREAS, in furtherance of same, it is necessary for the Township Committee of the Township of Franklin to authorize the Township Engineer to provide all required reports, narratives, estimates and maps required for said funding consideration not to exceed \$5,000.00.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Franklin that the Mayor is hereby authorized to execute the attached application with the NJDOT Transportation Trust Fund (FY2016 Municipal Aid Application) and the Township of Franklin for services associated with the project entitled Dutch Mill Road Improvements Project; and

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Franklin that the Township Engineer is hereby authorized to provide all required reports, narratives, estimates and maps required for the NJDOT Transportation Trust Fund (FY2016 Municipal Aid Application).
