

**TOWNSHIP OF FRANKLIN  
RESOLUTION AUTHORIZING THE TAX COLLECTOR  
AND TREASURER TO REFUND A \$ 1,177.15 PAYMENT MADE IN ERROR  
FOR PROPERTY TAXES FOR BLOCK 7101 LOT 47**

**WHEREAS**, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of certain monies paid in error by Corelogic; and

**WHEREAS**, John and Selina Rose are the owners of record of Block 7101, Lot 47 on the Tax Map of the Township of Franklin, also known as 1166 Harding Highway, Newfield, New Jersey; and

**WHEREAS**, on or about February 5, 2014, the Franklin Township Tax Collector received for the owners of record, the sum of \$ 1,177.15 from for real estate taxes due and owing for the premises.

**WHEREAS**, the Tax Collector of the Township of Franklin is in receipt of a request by Corelogic, Inc. for a refund of those excess monies paid on February 5, 2014 for Block 7101, Lot 47; and

**WHEREAS**, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the erroneous payment of taxes to Corelogic .

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 1,177.15, shall be refunded to Corelogic, 1 Corelogic Way, Westlake, TX 76262; and

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
