

**RESOLUTION  
TOWNSHIP OF FRANKLIN  
APPROVING THE PURCHASE OF A DEVELOPMENT  
EASEMENT ON BLOCK 7102, LOT 14 (REVISED)  
THE BRIAN AND DOROTHY KARGMAN FARM  
R-66-14**

**WHEREAS**, an amount of \$7,500.00 per acre has been accepted for the development easement on the Kargman farm Block 7102 Lot 14, containing 26.2 acres (after excluding a 0.101 acre and a 4.369 acre severable exception) which is contained in Franklin Township's Planning Incentive Grant list of farms; and

**WHEREAS**, to date \$750,000.00 in SADC funding has been approved by the Garden State Preservation Trust and subsequently appropriated by the State Agriculture Development Committee (SADC) for the purchase of development easements in Franklin Township; and

**WHEREAS**, Franklin Township has committed to provide a cost share of up to 20% for the purchase of the development easement on the Kargman farm cited above; and

**WHEREAS**, based on Franklin Township's application, the SADC and the County of Gloucester will provide the remaining 80% of the purchase of the development easements.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that:

- (1) The purchase of the development easement on Block 7102 Lot 14 (Kargman farm) is hereby approved;
- (2) It agrees to commit to funding the purchase of the development easement on Block 7102 Lot 14 (Kargman farm) and agrees to fund Franklin Township's portion of up to 20%, estimated to be \$33,335.00;
- (3) It will request the County of Gloucester to increase its share to help address any SADC shortfall, if necessary.

**AND BE IT FURTHER RESOLVED**, that the Municipal Clerk is directed to forward certified copies of this Resolution to the County Agricultural Development Board and the State Agricultural Development Committee as requested and required.
