

**RESOLUTION
TOWNSHIP OF FRANKLIN
GRANTING TAX EXEMPTION FOR TOTALLY DISABLED VETERAN**

WHEREAS, Raymond R. Martin, who resides at and is the owner of certain real estate in the Township of Franklin known as 1450 Fries Mill Road, Lot 54, Block 1903, Franklinville, NJ, is a permanently disabled veteran in accordance with the provisions of N.J.S.A. 54:4-3.30; and

WHEREAS, Mr. Martin made the appropriate claim for tax exemption as a 100% totally and permanently disabled veteran effective March 20, 2012; and

WHEREAS, the U.S. Department of Veterans' Affairs has confirmed this information by way of a letter dated August 19, 2014.

NOW THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the property known as 1450 Fries Mill Road, Lot 54, Block 1903, Franklinville, NJ, is hereby designated as a tax exempt property as the property owner, Raymond R. Martin, is an honorably discharged, 100% totally and permanently disabled veteran in accordance with the provisions of N.J.S.A. 54:4-3.30, and therefore the taxes on this property for the tax year of 2014 and all property taxes going forward are hereby cancelled. The sum of \$22,706.70, which represents the total amount of property tax paid for the following tax quarters: (1) February 2012: \$319.88, (2) May 2012: \$2,617.07, (3) August 2012: \$2,736.62, (4) November 2012: \$2,516.28, (5) February 2013: \$2,621.77, (6) May 2013: \$2,621.76, (7) August 2013: \$1,472.73, (8) November 2013: \$1,551.09, (9) February 2014: \$2,066.84, (10) May 2014: \$2,066.84, and (11) August 2014 \$2,115.82, shall be refunded to Mr. Martin by the Township. The sum of \$2,236.18, which represents the total amount of property tax due for the November 2014 tax quarter, and \$2,121.42, which represents the total amount of property tax due for the February 2015 tax quarter, and \$2,121.42, which represents the total amount of property tax due for the May 2015 tax quarter, shall be cancelled by the Township.
