

**TOWNSHIP OF FRANKLIN
RESOLUTION AUTHORIZING THE TAX COLLECTOR
AND TREASURER TO REFUND \$ 400.00 PAYMENT
APPLIED TO 2015 TAXES FROM HOMEOWNER SENDING PAYMENT IN
ERROR MORTGAGE COMPANY ESCROWS FOR TAXES
FOR BLOCK 1201 LOT 57.01**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund to the property owner for a payment applied toward 2015 Property Taxes when homeowner sent payment in error the Mortgage Company escrows for taxes; and

WHEREAS, Matthew & Robin Marinelli were the owners of record of Block 1201, Lot 57.01 on the Tax Map of the Township of Franklin, also known as 370 Pennsylvania Avenue; and

WHEREAS, in the 2014 Tax Year, this property received a payment from homeowner on November 7th, 2014 in the amount of \$ 400.00, after the Mortgage Company paid the November, 2014 tax quarter; and

WHEREAS, the Tax Collector of the Township of Franklin is in receipt of a request by homeowners for a refund in the amount of \$400.00 to be refunded directly to them for Block 1201, Lot 57.01; and

WHEREAS, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the payment of \$400.00 for taxes applied to 2015.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the payment of real property taxes in the amount of \$400.00, shall be refunded to homeowners, Matthew & Robin Marinelli, at 370 Pennsylvania Avenue, Franklinville, NJ 08322; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
