

**ORDINANCE
TOWNSHIP OF FRANKLIN
ORDINANCE CREATING A NEW CHAPTER OF THE CODE OF THE TOWNSHIP OF
FRANKLIN, COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY, ENTITLED
“PETTY CASH FUND”
O-5-15**

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF FRANKLIN, COUNTY OF GLOUCESTER, AND STATE OF NEW JERSEY, AS FOLLOWS:

Chapter . PETTY CASH FUND

§ -1 Establishment.

A Petty Cash Fund is hereby established pursuant to N.J.S.A. 40A:5-21.

§ -2 Amount of Fund.

The Petty Cash Fund shall be in the amount of \$300.00 per annum.

§ -3 Designated Custodian.

The designated custodian of the fund shall be the Township Clerk, who shall be bonded in the amount of \$1,000,000.00. Said custodian shall maintain records for the Petty Cash Fund in a manner conducive to proper accounting and auditing procedures.

BE IT FURTHER ORDAINED, that if any section, sentence, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of the competent jurisdiction, such holdings shall not effect or impair any other section, sentence, clause, provision or portion of this Ordinance.

BE IT FURTHER ORDAINED, that this Ordinance shall take effect immediately upon its final passage, adoption and publication provided by law.

The foregoing ordinance was introduced on first reading at a meeting of the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, held on, Tuesday, February 24, 2015 and will be read and considered for final passage at a meeting to be held by the Franklin Township Committee at the Municipal Building, 1571 Delsea Drive, Franklinville, New Jersey 08322 on Tuesday, March 24, 2015 at 7:00 p.m., at which time and place any and all interested persons will be given an opportunity to be heard.
