

**RESOLUTION  
TOWNSHIP OF FRANKLIN  
RESOLUTION AUTHORIZING A LIEN AGAINST  
BLOCK 2103, LOT 14, FOR COST OF PROPERTY MAINTENANCE  
PERFORMED BY TOWNSHIP EMPLOYEES PURSUANT TO  
FRANKLIN TOWNSHIP ORDINANCE SECTION 0-12-2010**

**R – 210 - 14**

**WHEREAS**, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, is in receipt of a report by the Superintendent of Public Works in connection with the Property Clean Up on the premises known as Block 2103, Lot 14, on the Tax Map of the Township of Franklin; and

**WHEREAS**, the owner of record, Clifton I & Marsha Arrington were advised by Franklin Township Administration to Clean Up the property 3167 Delsea Drive: and

**WHEREAS**, Franklin Township Department of Public works personnel performed the required property maintenance: and

**WHEREAS**, Section 0-12-2010 of the Franklin Township Code provides that the cost of property maintenance shall be charges against the land and shall be a first lien upon said lands and premises in the nature of taxes assessed against said lands; and

**WHEREAS**, the cost charges and collected against said premises is \$4750.00 which sum shall be a first lien against the premises in the nature of taxes;

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that pursuant to Section 0-12-2010 of the Township Code, the sum of \$4750.00 shall be a lien on the premises know as Block 2103, Lot 14, on the Tax Map of the Township of Franklin, the owner of record of which is Clifton I & Marsha Arrington; and

**BE IT FURTHER RESOLVED**, that the said sum shall be added to and become part of the taxes assessed against said lands and premises and shall be collected with and in the same manner and bear interest at the same rate as taxes upon said premises;

**ADOPTED**, at a regular meeting of the Township Committee of the Township of Franklin on December 29, 2014.
