

**ORDINANCE**  
**TOWNSHIP OF FRANKLIN**  
**O-7-15**  
**AMENDING CHAPTER 143-8, ALCOHOLIC BEVERAGES, OF THE**  
**FRANKLIN TOWNSHIP CODE**

**WHEREAS**, the Township of Franklin, County of Gloucester, State of New Jersey has within its code §143-8 which was amended in 1992 by Ordinance O-18-92; and

**WHEREAS**, The Township Committee of the Township of Franklin believes that it is appropriate to amend §143-8 to reestablish the hours of business.

**NOW THEREFORE, BE IT ORDAINED**, by the Township of Franklin, Committee of the Township of Franklin, County of Gloucester, State of New Jersey that §143-8 be and is hereby rescinded and replaced with the following:

No alcoholic beverages shall be sold, served, or delivered, nor shall any licensee suffer or permit the sale, service or delivery of any alcoholic beverage, directly or indirectly, upon the licensed premises between the hours of 2:00 AM and 7:00 AM on weekdays, and between the hours of 2:00 AM and 10:00 AM on Sundays. Time herein declared shall be the time officially in effect in the Township.

**BE IT FURTHER ORDAINED**, that if any section, sentence, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such holdings shall not effect or impair any other section, sentence, clause, provision or portion of this Ordinance.

**BE IT FURTHER ORDAINED**, that this ordinance shall take effect immediately upon its final passage, adoption and publication as provided by law.
