

**ORDINANCE 0-12-15**

**TOWNSHIP OF FRANKLIN**

**ORDINANCE PROHIBITING PARKING ALONG A CERTAIN SECTION OF  
MAIN ROAD WITHIN THE TOWNSHIP OF FRANKLIN**

**WHEREAS**, the Township Committee of the Township of Franklin, County of Gloucester and State of New Jersey, desires to create a no parking zone along a portion of Main Road from within the Township of Franklin; and

**WHEREAS**, in accordance therewith, the Township Committee desires to amend the Ordinances of the Township of Franklin, to accomplish this purpose.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Franklin, County of Gloucester and State of New Jersey that the codified ordinances of the Township of Franklin, shall be amended to state:

**SECTION I.** Parking of motor vehicles shall at all times be prohibited on the portion of Main Road as follows:

All that certain tract of land and premises situate being and lying in the Township of Franklin, County of Gloucester and State of New Jersey and being more particularly described as follows: 275 feet along the east side of Main Road from the county line to the bridge over Blackwater Branch, as well as for 238 feet along the west side of Main Road from the county line to the bridge over Blackwater Branch. The cost of the posting of signage will be borne by LKQ Penn-Mar Inc.

**SECTION II.** If any part or parts of this ordinance are for any reason, held to be invalid, such adjudication shall not affect the validity of the remaining portions of this ordinance.

**SECTION III.** All ordinances, or parts of ordinance, inconsistent herewith are hereby repealed to the extent of such inconsistency.
