

ORDINANCE
TOWNSHIP OF FRANKLIN
ORDINANCE AMENDING CHAPTER 247 – JUNK AND JUNK DEALERS - §247-8
RENEWALS
O-32-14

WHEREAS, the Township Committee of the Township of Franklin seeks to amend the Township Code, specifically Chapter 247 Junk and Junk Dealers, § 247-8 Renewal, in order to permit the Township to charge a late fee for failing to renew a license; and

NOW THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the codified Ordinance of the Township of Franklin shall be amended to state as follows in Chapter 247 Junk and Junk Dealers, § 247-8 Renewal:

Licenses shall be renewable on October 1 of each year upon application therefor and payment of the fee required by this chapter. No investigation is necessary on application for renewals. The Township Committee shall have the power to initiate its own investigation on application for renewals, however, and if it finds that conditions have now change since its prior investigation held thereon so that all provisions of this chapter are not complied with, the application for renewal shall be denied.. A licensee who fails to submit a renewal application by September 30, shall pay, in addition to the annual license fee, a late charge of \$100.00. The late charge shall not be the exclusive penalty, but shall be in addition to any other penalties provided for in this article.

BE IT FURTHER ORDAINED, that if any section, sentence, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of the competent jurisdiction, such holdings shall not effect or impair any other section, sentence, clause, provision or portion of this Ordinance.

BE IT FURTHER ORDAINED, that this Ordinance shall take effect immediately upon its final passage, adoption and publication provided by law.
