

**ORDINANCE**  
**TOWNSHIP OF FRANKLIN**  
**ORDINANCE AMENDING CHAPTER 83.- MEETINGS - ARTICLE I. TOWNSHIP**  
**COMMITTEE §83-1**  
**O-2-14**

**WHEREAS**, the Township Committee of the Township of Franklin seeks to amend the Township Code, specifically Chapter 83 Meetings, Article I Township Committee, § 83-1 Meeting Dates and Times in order to permit the Township Committee to have one continuous regular meeting for the purposes of economy and efficiency which may have, as a component part of the regular meeting, a “work session” to take place as part of the regular meeting; and

**WHEREAS**, once the “work session” portion of the meeting is concluded, the balance of the regular meeting can then begin without the necessity of holding a separate work session one hour prior to the commencement of the regular meeting as required by Subsection F of current § 83-1;

**NOW THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the codified Ordinance of the Township of Franklin shall be amended to state as follows in Chapter 83, Article I, § 83-1 Meeting Dates and Times, Subsection F:

F. The Township Committee may, as part of a regular meeting, have a portion of said regular meeting to be deemed a work session. The work session portion of the regular meeting will not need to be separately advertised and therefore the regular meeting shall commence at a time to be set in accordance with Subparagraph A above or by subsequently adopting a Resolution setting forth the dates, times and locations of regularly scheduled Township Committee meetings for the year, or portion of the year then remaining.

**BE IT FURTHER ORDAINED**, that if any section, sentence, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of the competent jurisdiction, such holdings shall not effect or impair any other section, sentence, clause, provision or portion of this Ordinance.

**BE IT FURTHER ORDAINED**, that this Ordinance shall take effect immediately upon its final passage, adoption and publication provided by law.
