

**ORDINANCE  
TOWNSHIP OF FRANKLIN  
AMENDING OF CHAPTER 373-15 OF THE CODE OF THE TOWNSHIP OF  
FRANKLIN  
O-12-14**

**WHEREAS**, There have been complaints by residents about truck traffic on Railroad Avenue, which is a residential road; and

**WHEREAS**, the Township Committee of the Township of Franklin is desirous of revising the Code of the Township of Franklin Section 373-15; and

**WHEREAS**, The Township Committee of the Township of Franklin, County of Gloucester , State of New Jersey desires to create a four ton weight limit restriction on Railroad Avenue for the entire length of the road; and

**WHEREAS**, after due deliberation and consultation with the Solicitor, the Township Committee has determined that the revisions and amendments to Chapter 373-15 of the Franklin Township Code are necessary and appropriate.

**NOW, THEREFORE**, the Township Committee of the Township of Franklin, in Gloucester County, New Jersey, does hereby adopt and enact the following amendments to Chapter 373 of the Township's Code:

Road:	Weight Limit Restriction:	Section:
Railroad Avenue	4 Tons	Entire Length

**BE IT FURTHER ORDAINED**, Any Ordinance or parts of ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed; and

**BE IT FURTHER ORDAINED**, that this Ordinance shall take effect immediately upon passage and publication in accordance with the laws of the State of New Jersey.
