

**ORDINANCE
TOWNSHIP OF FRANKLIN
ORDINANCE AMENDING SPEED LIMITS ALONG SECTIONS OF
ROSEMONT AVENUE AND LAKE ROAD
O-17-14**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey are charged with governing the health, safety and welfare of the residents of the Township of Franklin; and

WHEREAS, the Township Committee of the Township of Franklin has determined that certain sections of Rosemont Avenue and Lake Road qualifies as a residential district and that the speed limit should be 35 miles per hour in certain sections in accordance with State statute; and

WHEREAS, the Township Committee authorizes the Department of Public Works to install and maintain signs on Rosemont Avenue from Route 40 to Lake Road – 2000 l.f. and Lake Road from Route 40 to the Second Curve – 3100 l.f. to indicate the speed limit of 35 miles per hour in both directions under the jurisdiction of the Township of Franklin; and

WHEREAS, New Jersey statute N.J.S.A. 39:4-98(c) requires that municipal authority over municipal roadways governing speed limits be done by ordinance in order to be enforceable;

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey that Franklin Township Ordinance 373-26 be and is hereby amended as follows:

A. The speed limit for both directions of traffic along the streets or parts thereof described below and made part of this Chapter, are hereby established at the rate of speed indicated.

B. Regulatory and warning signs shall be erected and maintained to affect the designated speed limits:

Name of Street	Speed Limit	Limits
Rosemont Avenue	35	from Route 40 to Lake Rd.
Lake Road	35	from Rt. 40 To Second Curve

BE IT FURTHER ORDAINED, that all other ordinances or parts of this ordinance inconsistent herewith are hereby repealed to the extent of such inconsistency and the balance of Ordinance §373-26 shall remain in full force and effect;
