

**RESOLUTION  
TOWNSHIP OF FRANKLIN  
APPOINTING A SOLICITOR FOR THE TOWNSHIP OF FRANKLIN  
FOR THE YEAR 2012, PURSUANT TO THE LOCAL PUBLIC CONTRACTS  
LAW (N.J.S.A. 40A:11-1, ET SEQ.)**

**R - 1 - 2012**

**WHEREAS**, there exists a need for a Solicitor in the Township of Franklin for the purposes of providing the Township Committee of said Township with legal counsel and advise; and

**WHEREAS**, pursuant to the provisions of N.J.S.A. 19:44A-20.5, the Township Committee has determined to award said contract as a fair and open contract; and

**WHEREAS**, funds are or will be available for this purpose; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires the governing body of a contracting unit to publish a notice in a newspaper authorized by law to publish its legal advertisements, setting forth the nature, duration, service and amount of the contract where such contract is awarded for "professional services".

**NOW THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, as follows:

1. That WILLIAM F. ZIEGLER, ESQUIRE, and the law firm of HOLSTON, MAC DONALD, UZDAVINIS, ZIEGLER & LODGE, 66 Euclid Street, P.O. Box 358, Woodbury, NJ 08096-7358, are hereby retained as Solicitor for the Township of Franklin, to provide counsel, advice and legal services to the officials of said Township for the year 2012.

2. The appropriate officers of the Township of Franklin are hereby authorized to enter into the contract with WILLIAM F. ZIEGLER and the law firm of HOLSTON, MAC DONALD, UZDAVINIS, ZIEGLER & LODGE for the legal services above specified, for a term of one year as attached hereto for the year 2012.

3. The contract is awarded as a "professional service" under the provision of the Local Public Contracts Law because of the specialized training, education, experience and specialized knowledge needed for this position and pursuant to a "fair and open" process as provided in N.J.S.A. 19:44A-20.4 et seq.

4. A notice of the award of this contract shall forthwith be printed once in The Gloucester County Times, an official newspaper of the Township of Franklin, authorized by law to publish the legal advertisements of the Township Committee of the Township of Franklin, setting forth the nature, duration, service and amount of the contract, and further stating that this resolution and the annexed contract are on file and available for public inspection in the Office of the Clerk of the Township of Franklin.

**AGREEMENT BETWEEN THE  
TOWNSHIP OF FRANKLIN AND WILLIAM F. ZIEGLER, ESQUIRE**

**WHEREAS**, the Township of Franklin, hereinafter referred to as "Township", requires the services of a Township Solicitor for the calendar year 2012, commencing January 1, 2012; and

**WHEREAS**, WILLIAM F. ZIEGLER, ESQUIRE and the Law Firm of Holston MacDonald Uzdavinis, Ziegler & Lodge, PC of 66 Euclid Street Woodbury, New Jersey 08096 hereinafter referred to as "Township Solicitor" are licensed attorneys in the State of New Jersey, and have agreed to accept the appointment of the Township for the performance of the duties of attorney subject to the following terms and conditions:

**WITNESSETH:**

1. The Township Solicitor shall be appointed to represent the Township for a term of one (1) year, commencing January 1, 2012, and he shall perform all duties required of a local representative of the Township.

2. During the term of this Agreement, the Township Solicitor shall devote his best efforts to advance the interest of the Township; he shall perform his duties to the best of his ability and in accordance with the Code of Professional Ethics by the New Jersey Supreme Court.

3. The Township Solicitor shall receive fees in the amount of \$115.00 per hour to serve as Township Solicitor. The Solicitor shall be entitled to receive compensation for his attendance at meetings, both regular and special, for the preparation of Ordinances, Resolutions, Contracts, Deeds and other legal documents not specifically enumerated herein, the handling of tax foreclosures, the representation of the Township and its officers including appearances before courts, Administrative bodies, Federal, State or County agencies, and services rendered for such other legal work, including correspondence, telephone calls or research as may be required to properly represent and advise the Mayor, Township Committee and other officials of the Township of Franklin. In addition, the Township Solicitor shall be entitled to receive medical insurance benefits provided to municipal employees provided that the Solicitor shall pay all premiums associated therewith plus administrative fees in accordance with municipal ordinances. Payment for services rendered by the Municipal Solicitor shall be at the level of fees predominate in the legal profession of the County of Gloucester, and shall be on the basis of statements rendered monthly for services performed and advice rendered.

4. The Township Solicitor shall also be entitled to be reimbursed for toll telephone calls, photostatic copying expenses, travel expenses and court costs, all of which may be billed to the Township on appropriate vouchers and reimbursed, upon approval, to the Solicitor.
