

**TOWNSHIP OF FRANKLIN
RESOLUTION AUTHORIZING THE TAX COLLECTOR
AND TREASURER TO REFUND \$ 2,017.12 OVERPAYMENT
RESULTING FROM A REDUCTION IN TAX ASSESSMENT
FOR BLOCK 7004 LOT 7.**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of overpayment of 2006 Property Taxes that has been transferred forward by Resolution each year; and

WHEREAS, Genco Homes – Strawberry Ave., LLC is the owner of record of Block 7004, Lot 7 on the Tax Map of the Township of Franklin, also known as 3555 Grace Ann Drive; and the property was sold to the Homeowners Association; and

WHEREAS, in the 2005 Tax Year, this property was billed Rollback Taxes which incorrectly increased the 2006 First Half Tax Billing creating an overpayment of Property Taxes due to the Overbill of 2006 Property Taxes. This overpayment has been transferred forward by Resolution every year; and

WHEREAS, the Tax Collector of the Township of Franklin is in receipt of a request by Hoffman DiMuzio, for Genco Homes – Strawberry Ave., LLC, for a refund of the Overpayment of \$ 2,017.12 to be refunded for Block 7004 Lot 7; and

WHEREAS, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the erroneous payment of taxes to Genco Homes – Strawberry Ave., LLC.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 2,017.12, shall be refunded to Genco Homes – Strawberry Ave., LLC, P.O. Box 274, Richwood, NJ 08074-0274; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
