

**TOWNSHIP OF FRANKLIN  
RESOLUTION AUTHORIZING THE TAX COLLECTOR  
AND TREASURER TO REFUND \$ 328.00 OVERPAYMENT  
RESULTING FROM HOMESTEAD REBATE PAYMENT  
FOR BLOCK 3707 LOT 5.01**

**WHEREAS**, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of a payment from the State of New Jersey for a Homestead Rebate on a property that is Tax Exempt; and

**WHEREAS**, Murphy, Michael A. Sr. and Kathy S. are the owners of record of Block 3707, Lot 5.01 on the Tax Map of the Township of Franklin, also known as 49 Sandpiper Drive; and the property owner is a Totally Disabled Veteran, therefore making the property Tax Exempt; and

**WHEREAS**, in the 2012 Tax Year, this property received a Homestead Rebate Credit from the State of New Jersey creating an overpayment on a Tax Exempt property; and

**WHEREAS**, the Tax Collector of the Township of Franklin is in receipt of a request by Michael A. Murphy for a refund of the Homestead Rebate of \$ 328.00 to be refunded for Block 3707 Lot 5.01; and

**WHEREAS**, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the Homestead Rebate to Murphy, Michael A. Sr. and Kathy S.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Homestead Rebate in the amount of \$ 328.00, shall be refunded to Murphy, Michael A. Sr. and Kathy S, 49 Sandpiper Drive, Franklinville, NJ 08322; and

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
