

**TOWNSHIP OF FRANKLIN
RESOLUTION AUTHORIZING THE TAX COLLECTOR
AND TREASURER TO REFUND A \$ 964.24 OVERPAYMENT
OF PROPERTY TAXES FOR BLOCK 402 LOT 25.**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of certain monies paid in error by Wells Fargo Home Mortgage; and

WHEREAS, Janet Reeves are the owners of record of Block 402, Lot 25 on the Tax Map of the Township of Franklin, also known as 4401 Tuckahoe Road, Franklinville, New Jersey; and

WHEREAS, on or about April 20, 2012, the Franklin Township Tax Collector received for the owners of record, the sum of \$ 964.24 from Access Abstract for real estate taxes due and owing for the premises, and on April 24, 2012 a payment was received from Wells Fargo Home Mortgage creating an overpayment in the amount of \$ 964.24; and

WHEREAS, the Tax Collector of the Township of Franklin is in receipt of a request by Wells Fargo Home Mortgage for a refund of those excess monies paid on April 24, 2012 for Block 402, Lot 25; and

WHEREAS, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the erroneous payment of taxes to Wells Fargo Home Mortgage .

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 964.24, shall be refunded to Wells Fargo Home Mortgage, MAC X0501-052, 1003 E. Brier Drive, San Bernadino, CA 92408; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
