

**TOWNSHIP OF FRANKLIN

AND TREASURER TO REFUND \$ 1,802.57 RECEIVED FOR PROPERTY
TAXES FOR A TOTALLY DISABLED VETERAN
FROM CORELOGIC REAL ESTSTE TAX SERVICES
AND CANCELLATION OF 2012 TAXES
FOR BLOCK 3501 LOT 4.**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing the cancellation of Property Taxes for a Totally Disabled Veteran and to refund of certain payments made by CoreLogic Real Estate Tax Services; and

WHEREAS, Victoria Lebens and Sherwood Gaunt are the owners of record of Block 3501, Lot 4 on the Tax Map of the Township of Franklin, also known as 927 Porchtown Road, Franklinville, New Jersey; and

WHEREAS, Sherwood Gaunt qualifies as a Tax Exempt Totally Disabled Veteran as of February 1, 2012 and Property Taxes are to be cancelled as per "Schedule A" attached; and

WHEREAS, CoreLogic Real Estate Tax Services has paid the taxes for the February and May 2012 Tax Quarters and the cancellation of Property Taxes is necessary due to Sherwood Gaunt being approved as a Tax Exempt Totally Disabled Veteran creates an overpayment of taxes to be refunded in the amount of \$1,802.57 as per "Schedule B" attached; and

WHEREAS, the Tax Collector of the Township of Franklin is in receipt of a request by CoreLogic Real Estate Tax Services for a refund of those taxes paid for Block 3501, Lot 4; and

WHEREAS, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the payment of taxes to CoreLogic Real Estate Tax Services

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the payment of real property taxes in the amount of \$ 1,802.57 shall be refunded to by CoreLogic Real Estate Tax Services, Refund Unit, 1 Core Logic Drive, Westlake, TX 76262; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
