

**RESOLUTION
TOWNSHIP OF FRANKLIN
RESOLUTION AUTHORIZING CANCELLATION OF TAX CERTIFICATE
NUMBER 11-00233 ISSUED TO THE TOWNSHIP OF FRANKLIN**

WHEREAS, on December 15, 2010, the Tax Collector of the Township of Franklin conducted a tax sale for unpaid taxes on real property located in the Township of Franklin at Block 7202, Lot 22, Township of Franklin, County of Gloucester, also known as Harding Highway (“Property”); and

WHEREAS, there was no purchaser for the tax lien on the Property and Tax Sale Certificate Number 10-00250 was issued to the Township of Franklin for such unpaid taxes; and

WHEREAS, on December 23, 2011, the Tax Collector of the Township of Franklin conducted a tax sale for unpaid taxes on the Property; and

WHEREAS, there was no purchaser for the tax lien on the Property and Tax Certificate Number 11-00233 was issued to the Township of Franklin for such unpaid taxes; and

WHEREAS, Tax Sale Certificate Number 11-00233 should not have been issued to Franklin Township but, rather, the unpaid taxes should have been added to Tax Sale Certificate No. 10-00250;

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Tax Collector for a Resolution authorizing the cancellation of Tax Certificate Number 11-00233; and

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, after due deliberation, has determined that it is appropriate to authorize the cancellation of Tax Sale Certificate Number 11-00233;

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, as follows:

1. The Tax Collector is hereby authorized to cancel Tax Sale Certificate Number 11-00233; and
2. Any subsequent taxes due and owing on the Property shall be and are hereby included as part of Tax Certificate Number 10-00250 in accordance with applicable statutory authority.
3. The Clerk of the Township of Franklin is hereby directed to provide the Township of Franklin Tax Collector with a certified copy of this Resolution.
