

**TOWNSHIP OF FRANKLIN
RESOLUTION AUTHORIZING THE TAX COLLECTOR
AND TREASURER TO REFUND \$ 520.47 OVERPAYMENT
RESULTING FROM A REDUCTION IN TAX ASSESSMENT.
FOR BLOCK 1101 LOT 106.**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of overpayment of 2013 Property Taxes due to a reduction in assessment from a successful Tax Appeal from the Gloucester County Board of Taxation; and

WHEREAS, Andrew A. Zeugner is the owner of record of Block 1101, Lot 106 on the Tax Map of the Township of Franklin, also known as Stanton Avenue; and

WHEREAS, in the 2012 Tax Year, this property had a successful Tax Appeal reducing the Tax Assessment for 2012 creating an overpayment of Property Taxes due to the Overbill of 2012 Property Taxes. This overpayment has been transferred forward by Resolution to 2013; and

WHEREAS, the Tax Collector of the Township of Franklin is in receipt of a request by Andrew A. Zeugner, for a refund of the Overpayment of \$ 520.47 to be refunded for Block 1101 Lot 106; and

WHEREAS, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the overpayment payment of taxes to Andrew A. Zeugner.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 520.47, shall be refunded to Andrew A. Zeugner, 1143 Stanton Avenue, Franklinville, NJ 08322; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
