

**TOWNSHIP OF FRANKLIN
RESOLUTION AUTHORIZING THE TAX COLLECTOR
AND TREASURER TO REFUND \$ 1,234.05 OVERPAYMENT
RESULTING FROM A DUPLICATE PAYMENT FROM
WELLS FARGO REAL ESTATE TAX SERVICES
FOR BLOCK 3002 LOT 4.**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of overpayment of 2012 Property Taxes due to a duplicate tax payment from Wells Fargo Real Estate Tax Services; and

WHEREAS, Diane Blasi is the owner of record of Block 3004, Lot 4 on the Tax Map of the Township of Franklin, also known as 941 Reed Avenue; and

WHEREAS, in the 2012 Tax Year, this property received a payment from Wells Fargo Real Estate Tax Services on August 8, 2012 in the amount of \$ 1,1234.05 and on again August 9, 2012 received a second payment of \$ 1,234.05 in a bulk wire payment from Wells Fargo Real Estate Tax Services; and

WHEREAS, the Tax Collector of the Township of Franklin is in receipt of a request by Wells Fargo Real Estate Tax Services, for a refund of the Overpayment of \$ 1,234.05 to be refunded for Block 3004, Lot 4; and

WHEREAS, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the overpayment payment of taxes to Wells Fargo Real Estate Tax Services.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 1,234.05, shall be refunded to Wells Fargo Real Estate Tax Services, Attn: Financial Support Unit, 1 Home Campus, MAC X302-04D, Des Moines, IA 50328; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
