

**TOWNSHIP OF FRANKLIN  
RESOLUTION AUTHORIZING THE TAX COLLECTOR  
AND TREASURER TO REFUND \$ 1,821.06 OVERPAYMENT  
RESULTING FROM A DUPLICATE PAYMENT FROM  
EAST GATE TITLE, LLC  
FOR BLOCK 6501 LOT 24.**

**WHEREAS**, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund to the property owner of an overpayment of 2012 Property Taxes due to a duplicate tax payment from East Gate Title, LLC; and

**WHEREAS**, Regina Gatti is the owner of record of Block 6501, Lot 24 on the Tax Map of the Township of Franklin, also known as 721 Whitehall Road; and

**WHEREAS**, in the 2012 Tax Year, this property received a payment from East Gate Title, LLC on October 24, 2012 in the amount of \$ 1,821.06 and on again November 8, 2012 received a second payment of \$ 928.12 in a bulk payment from Corelogic Real Estate Tax Service, LLC; and

**WHEREAS**, the Tax Collector of the Township of Franklin is in receipt of a request by East Gate Title, LLC, for a refund of the Overpayment of \$ 1,821.06 to be refunded for Block 6501, Lot 24; and

**WHEREAS**, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the overpayment payment of taxes to East Gate Title, LLC.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 1,821.06, shall be refunded to Regina Gatti, 721 Whitehall Road, Newfield, New Jersey 08344; and

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
