AND TREASURER TO REFUND \$ 390.20 OVERPAYMENT
RESULTING FROM A DUPLICATE PAYMENT FROM
FRED T. AND MICHELLE S. PARSONS
FOR BLOCK 6002 LOT 56.**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of overpayment of 2012 Property Taxes due to a duplicate tax payment from Fred T. and Michelle S. Parsons; and

WHEREAS, Fred T. and Michelle S. Parsons is the owner of record of Block 6002, Lot 56 on the Tax Map of the Township of Franklin, also known as 2495 North Blue Bell Road; and

WHEREAS, in the 2012 Tax Year, this property received a payment from Fred T. and Michelle S. Parsons on October 26, 2012 in the amount of \$ 390.20 and on again November 8, 2012 received a second payment of \$ 390.20 in a bulk payment from Corelogic Real Estate Tax Service, LLC; and

WHEREAS, the Tax Collector of the Township of Franklin is in receipt of a request by Fred T. and Michelle S. Parsons, for a refund of the Overpayment of \$ 390.20 to be refunded for Block 6002, Lot 56; and

WHEREAS, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the overpayment payment of taxes to Fred T. and Michelle S. Parsons.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 390.20, shall be refunded to Fred T. and Michelle S. Parsons, 2495 North Blue Bell road, Franklinville, NJ 08322; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
