

**TOWNSHIP OF FRANKLIN
RESOLUTION AUTHORIZING THE TAX COLLECTOR
AND TREASURER TO REFUND \$ 1,597.36 OVERPAYMENT
RESULTING FROM A DUPLICATE PAYMENT FROM
WILLIAM AUGE JR. AND MARY K. ANNUZZI-AUGE
FOR BLOCK 3908 LOT 20.**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of overpayment of 2012 Property Taxes due to a duplicate tax payment from William Auge Jr and Mary K. Annuzzi-Auge; and

WHEREAS, William Auge Jr and Mary K. Annuzzi-Auge is the owner of record of Block 3802, Lot 20 on the Tax Map of the Township of Franklin, also known as 533 Judy Avenue; and

WHEREAS, in the 2012 Tax Year, this property received a payment from William Auge Jr and Mary K. Annuzzi-Auge on November 5, 2012 in the amount of \$ 1,597.36 and on again November 8, 2012 received a second payment of \$ 1,597.36 in a bulk payment from Wells Fargo; and

WHEREAS, the Tax Collector of the Township of Franklin is in receipt of a request from Wells Fargo for William Auge Jr and Mary K. Annuzzi-Auge, for a refund of the Overpayment of \$ 1,597.36 to be refunded for Block 3802, Lot 20; and

WHEREAS, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the overpayment payment of taxes to William Auge Jr and Mary K. Annuzzi-Auge.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 1,597.36, shall be refunded to William Auge Jr and Mary K. Annuzzi-Auge, 533 Judy Avenue, Franklinville, NJ 08322; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
