

**TOWNSHIP OF FRANKLIN
RESOLUTION AUTHORIZING THE TAX COLLECTOR
AND TREASURER TO REFUND \$ 530.49 OVERPAYMENT
RESULTING FROM A DUPLICATE PAYMENT FROM
GMAC MORTGAGE
FOR BLOCK 1701 LOT 19.02.**

WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund to the property owner of an overpayment of 2012 Property Taxes due to a duplicate tax payment from GMAC Mortgage; and

WHEREAS, Lee Braddock and Kathy A Wingate are the owners of record of Block 1701, Lot 19.02 on the Tax Map of the Township of Franklin, also known as 1990 Williamstown Road; and

WHEREAS, in the 2012 Tax Year, this property received a payment from Corelogic Real Estate Tax Service, LLC, for GMAC Mortgage on October 26, 2012 in the amount of \$ 530.49 and on again November 8, 2012 received a second payment of \$ 530.49 in a bulk payment from Corelogic Real Estate Tax Service, LLC; and

WHEREAS, the Tax Collector of the Township of Franklin is in receipt of a request by GMAC Mortgage, for a refund of the Overpayment of \$ 530.49 to be refunded for Block 1701, Lot 19.02; and

WHEREAS, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the overpayment payment of taxes to GMAC Mortgage.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Overpayment of real property taxes in the amount of \$ 530.49, shall be refunded to GMAC Mortgage, P.O. Box 961219, Ft. Worth, TX 76161-0219; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
