WHEREAS, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of certain monies paid in error by BAC Tax Services Corp.; and

WHEREAS, Jennifer Piraino are the owners of record of Block 5504, Lot 7 on the Tax Map of the Township of Franklin, also known as 1217 West Blvd., Newfield, New Jersey; and

WHEREAS, on or about April 21, 2011, the Franklin Township Tax Collector received for the owners of record, the sum of \$ 1,066.53 by error from BAC Tax Services Corp. for real estate taxes due and owing for the premises; and

WHEREAS, Block 5504, Lot 7, 1217 West Blvd. is a non escrow account and BAC Tax Services Corp. should not have paid the taxes; and

WHEREAS, the Tax Collector of the Township of Franklin is in receipt of a request by BAC Tax Services Corp. for a refund of those excess monies paid in error for Block 5504, Lot 7; and

WHEREAS, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the erroneous payment of taxes to BAC Tax Services Corp.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the erroneous of real property taxes as listed above, shall be refunded to BAC Tax Services Corp. Ref. # 533619546, P.O. Box 10211, CA6-913-LB-01, Van Nuys, CA 91499.; and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
