AND TREASURER TO REFUND \$ 164.00 HOMESTEAD REBATE RECEIVED  
FOR TOTALLY DISABLED VETERAN FOR BLOCK 4810 LOT 4**

**WHEREAS**, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of certain monies paid by the State of New Jersey; and

**WHEREAS**, Richard E. and Helen B. Kilroy are the owners of record of Block 4810, Lot 4 on the Tax Map of the Township of Franklin, also known as 20 Balsam Court, Malaga, New Jersey; and

**WHEREAS**, on or about May 1, 2011, the Franklin Township Tax Collector received for the owners of record, a Homestead Rebate in the amount of \$ 132.05 from the State of New Jersey for real estate taxes on a Tax Exempt Totally Disabled Veteran; and

**WHEREAS**, the Division of Local Government Services has informed the Tax Collector of Franklin Township that the Homestead Rebate shall be refunded to the above homeowners; and

**WHEREAS**, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the Homestead Rebate to Richard E. and Helen B. Kilroy.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the Homestead Rebate be sent to Richard E. and Helen B. Kilroy, 20 Balsam Court, Malaga, New Jersey; 08328, and

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
