**WHEREAS**, the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey is in receipt of a request from the Municipal Tax Collector of the Township of Franklin for a Resolution authorizing a refund of certain monies paid in error by CoreLogic Real Estate Tax Services; and

**WHEREAS**, Michael A. Sr. and Kathy S. Murphy are the owners of record of Block 3707, Lot 5.01 on the Tax Map of the Township of Franklin, also known as 49 Sandpiper Drive, Franklinville, New Jersey; and

**WHEREAS**, on or about August 26, 2011, the Franklin Township Tax Collector received for the owners of record, the sum of \$ 820.23 in error from by CoreLogic Real Estate Tax Services for a Tax Exempt Totally Disabled Veteran; and

**WHEREAS**, Block 3707, Lot 5.01, 49 Sandpiper Drive is a Tax Exempt Totally Disabled Veteran account and CoreLogic Real Estate Tax Services should not have paid the taxes; and

**WHEREAS**, the Tax Collector of the Township of Franklin is in receipt of a request by CoreLogic Real Estate Tax Services for a refund of those excess monies paid in error for Block 3707, Lot 5.01; and

**WHEREAS**, after due deliberation and discussion with the Township Administrator, Treasurer, and Tax Collector, the Township Committee of the Township of Franklin, County of Gloucester has determined that it is appropriate for the Township of Franklin to refund the erroneous payment of taxes to CoreLogic Real Estate Tax Services

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that the erroneous of real property taxes as listed above, shall be refunded to by CoreLogic Real Estate Tax P.O. Box 961250, Ft. Worth, TX 76161-9887; and

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be forwarded to the Tax Collector and Treasurer of the Township of Franklin for their records.
