

**RESOLUTION  
TOWNSHIP OF FRANKLIN  
DETERMINING THAT CERTAIN ITEMS OF PERSONAL PROPERTY OWNED BY

PUBLIC USE, AND AUTHORIZING THE SALE OF SAID ITEMS AT PUBLIC

**WHEREAS**, the Township of Franklin has recently determined that the items of personal property which are set forth in the list annexed to this resolution are not needed for public use; and

**WHEREAS**, the Township of Franklin Committee has further determined that it would be in the best interest of the Township to sell said items of personal property at public auction to the highest bidder; and

**WHEREAS**, the Township of Franklin has determined to authorize T.J. Sullins, an auctioneer, to sell said property at public sale to be held on Saturday, November 19, 2011 at Newfield Auction Company, 7 Salem Avenue, Newfield, New Jersey 08344 commencing at 10:00 AM after due notice and publication of said sale,

**NOW THEREFORE BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF  
THE TOWNSHIP OF FRANKLIN, COUNTY OF GLOUCESTER AS FOLLOWS:**

The Township Committee of the Township of Franklin hereby determines that the said personal property described on the attached list, were either forfeited to or purchased by the Township are not needed for public use, and that it is in the public interest that said property be sold at public sale to the highest bidder.
2. The Township Committee has designated T. J. Sullins as the Township's representative to sell the personal property described on the annexed list for sale to the highest bidder at public auction to be held on Saturday, November 19, 2011 at Newfield Auction Company, Newfield, NJ commencing at 10:00 AM.
3. After receipt of bids on a particular item of personal property, the Auctioneer conducting the auction is hereby authorized to finalize the sale to the highest bidder, collect the amount of bid for the highest bidder and to deliver the item of personal property to the bidder.
4. There is no assurance that any property sold at public auction is fit for any particular use by purchaser and the Township Committee makes no warranties as to the nature or condition of any item of personal property set forth on the annexed list.
