ORDINANCE AUTHORIZING THE SALE OF TOWNSHIP OWNED PROPERTY

WHEREAS, the Township of Franklin is the owner of certain undersized lands identified as Block 5312 Lot 4; Block 5314 Lots 3 and 5; Block 4726 Lots 1 and 5; Block 4724 Lots 1, 2 and 3; Block 4820 Lots 1,2,4,5,6, 7 and 12; Block 4822 Lot 2; and Block 4823 Lots 2,4,5,7 and 8; on the Tax Assessment Map of Franklin Township; and

WHEREAS, said properties are not needed for public use by the Township of Franklin; and

WHEREAS, the Township Committee is desirous of selling said properties at private sale to contiguous property owners, pursuant to N.J.S.A. 40A:12-13(b), subject to Block 5312 Lot 4 being sold subject to the highest bid and subject to a minimum bid of two thousand six hundred dollars (\$2,600.00) and for Block 5314 Lots 3 and 5 being sold as one parcel and subject to a minimum bid of seventeen thousand eight hundred dollars (\$17,800.00) and for Block 4724 Lots 1, 2 and 3 being sold as one parcel and subject to a minimum bid of six thousand four hundred eighty five dollars (\$6,485.00) and Block 4726 Lots 1 and 5 being sold as one parcel and subject to a minimum bid of thirteen thousand three hundred forty dollars (\$13,340.00) and Block 4820 Lots 1,2,4,5,6,7, and 12 being sold as one parcel and subject to a minimum bid of six thousand four hundred eighty dollars (\$6,480.00); and Block 4822 Lot 2 subject to a minimum bid of five hundred fifty dollars (\$550.00); and Block 4823 Lots 2,4,5,7 and 8 being sold as one parcel and subject to a minimum bid of fifteen thousand one hundred ninety dollars (\$15,190.00) any conditions as hereinafter set forth; and

WHEREAS, the properties are sold "as is, where is" and the Township does not make any representations as to the properties;

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that Block 5312 Lot 4; Block 5314 Lots 3 and 4; Block 4724 Lots 1, 2 and 3; Block 4726 Lots 1 and 5; Block 4820 Lots 1,2,4,5,6,7 and 12; Block 4822 Lot 2; Block 4823 Lots 2,4,5,7 and 8 owned by the Township are not needed for public use, shall be sold to a contiguous landowner by sealed bid; and

BE IT FURTHER ORDAINED, all bids must be received by the Township Clerk's Office prior to 1:00 P.M. on Friday, MARCH 5, 2010 at which time all bids will be opened; and

BE IT FURTHER ORDAINED, that each bidder is required to submit a deposit at the time of the bid of 10% of their bid, by cash or check; money order, or cashier's check; and

BE IT FURTHER ORDAINED, the balance of the purchase price for the above properties shall be paid to the Township Clerk by cash or certified check; money order, or cashier's check on or before 12:00 noon on FRIDAY, APRIL 2, 2010; and

BE IT FURTHER ORDAINED, in the event the successful bidders fail to pay the balance of the purchase price within the time specified, the Township Committee reserves the right to cancel the sale and retain the deposit as liquidated damages and sell the properties to the next highest bidder under the same terms and conditions; and

BE IT FURTHER ORDAINED, that the proper officials of the Township Committee are authorized to execute documents to complete such sale; and

BE IT FURTHER ORDAINED, the Township Committee reserves the right to reject any and all bids.
