

**ORDINANCE
TOWNSHIP OF FRANKLIN
O-10-2010**

**ORDINANCE AMENDING §95-10 OF THE CODE OF THE TOWNSHIP OF FRANKLIN,
AS FOLLOWS:**

WHEREAS, the Township of Franklin had established Chapter 24 of the Township Code, creating the position of the Code Enforcement Officer and enumerating the duties of the Code Enforcement Officer therein; and

WHEREAS, the Township of Franklin has determined that the position of Code Enforcement Officer is unnecessary as the duties of the Code Enforcement Officer can be performed by the Planning and Zoning Administrative Officer; and

WHEREAS, §95-10 of the Code of the Township of Franklin sets forth the powers and duties of the Planning and Zoning Administrative Officer; and

NOW THEREFORE, BE IT ORDAINED, by the Township of Franklin, Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that §95-10, of the Township Code is hereby amended as follows:

F. Enforce the ordinances as set forth in the Code of the Township of Franklin, including but not limited to the following:

- G. Although the Planning and Zoning Administrative Officer's responsibility shall be the enforcement of the above enumerated ordinances, other municipal employees and officials may also enforce said ordinances, and the delegation of this enforcement duty to the Planning and Zoning Administrative Officer shall not preclude others from enforcing said ordinances.
- H. The Planning and Zoning Administrative Officer shall make investigations, serve violations notices, make and process complaints for Code violations and make court appearances, both municipal and otherwise, as necessary in connection therewith.
- I. The Planning and Zoning Administrative Officer shall attend all meetings of the Planning Board, Board of Adjustment and other meetings as may be necessary and/or requested by the Township Committee.
- J. The Planning and Zoning Officer shall render a written report monthly or as requested to the Township Administrator and to the Mayor and Township Committee of his or her findings and actions taken in the performance of duties.
