**AN ORDINANCE OF THE TOWNSHIP OF FRANKLIN,  
COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY  
AUTHORIZING THE USE OF MUNICIPAL LOCAL AID FUNDS  
FOR PENNSYLVANIA AVENUE**

**O-2-09**

WHEREAS, Franklin Township has been selected to receive funding from the New Jersey Department of Transportation's (NJDOT) Fiscal Year 2009 Municipal Local Aid Program for Pennsylvania Avenue, in the amount of \$214,000.00; and

WHEREAS, the improvements to Pennsylvania Avenue will strengthen the local transportation network, providing a substantial benefit to the citizens of Franklin Township; and

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Franklin, County of Gloucester and State of New Jersey, that the funds received from NJDOT's Municipal Local Aid Program shall be used to complete the Pennsylvania Avenue project; and

BE IT FURTHER ORDAINED, that a certified copy of this Ordinance shall be provided to State of New Jersey, Department of Transportation, Commissioner of Transportation for his records; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent that they are inconsistent; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances not inconsistent with this ordinance shall remain in full force and effect; and

This ordinance shall take effect immediately.
