

**ORDINANCE
TOWNSHIP OF FRANKLIN
AUTHORIZING THE TOWNSHIP OF FRANKLIN TO EXPEND A PORTION
OF THE FUNDS MAINTAINED BY THE TOWNSHIP IN THE RECREATION
FACILITIES/OPEN SPACE DEDICATED TRUST FUND**

WHEREAS, the Township Committee of the Township of Franklin maintains a dedicated trust fund for the deposit of funds received by the Township as payment by developers related to open space and recreational facilities; and

WHEREAS, the Township Code §253-50(h) indicates that expenditures shall be authorized to be made for the recreation open space reserves for the acquisition and development costs and incidentals related to charges for open space and recreational facilities; and

WHEREAS, the Planning Board in conjunction with the recreation committee have provided a list of proposed expenditures for those purposes which will benefit the public health, safety, morals and welfare; and

NOW THEREFORE, BE IT ORDAINED, by the Township of Franklin, County of Gloucester, State of New Jersey that the Township's Chief Financial Officer is authorized to expend a portion of the funds within the recreation facilities/open space dedicated trust fund in amounts not to exceed the amounts set forth on the attached schedule; and

BE IT FURTHER ORDAINED, that all such expenditures shall be supported by public bids to be supervised and conducted by the Township's Chief Financial Officer; and

BE IT FURTHER ORDAINED, that if any section, sentence, clause, provision or portion of this ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction that such holding shall not affect or impair any other section, sentence, clause, provision or portion of this Ordinance; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect immediately upon its final passage, adoption, publication as provided by law.

PROPOSED RECREATION PROJECTS

- **Soccer;** the installation of a irrigation well, associated piping and irrigation gun to properly irrigate the Franklin Township Soccer Complex on Dutchmill Road – value \$20,000.00. Fencing at the soccer fields – value \$6,000; total valued \$26,000
- **Wrestling Program;** a wrestling mat, to be utilized by the club team, the youth organization, the middle school, and the high school – value \$10,000.00.
- **Delsea;** security lights installed on the track at the stadium, to allow the use after dusk, ventilation fans installed in the weight room and update certain gym equipment – value \$40,000.00.
- **Roller Hockey;** installation of an electronic scoreboard and bleachers – value \$10,000.00. Replacement of plywood, posts and paint – value \$7500.00 total value - \$17,500.00
- **Little League;** Two (2) batting cages – value \$10,000.00, two (2) new scoreboards – value \$10,000.00, repair three (3) old score boards – value \$3,000.00 and a 30' X 40' pole barn – value \$20,000.00. Total value - \$43,000.00
- **Train Station;** to replace the siding, roofing, installation of the loading dock and electrical service to the train station – value \$20,000.00.
- **Football;** three (3) sets of bleachers – value \$20,000.00, expand practice field, rearrange the parking area and fence the end zone to the woods line - \$10,000.00. Total value \$30,000.00.
- **Sound System;** \$13,966.00 Broadway Bound Players and other recreation organizations as needed.
- **Library;** lighting retrofit - value \$9,696.55
