

**ORDINANCE  
TOWNSHIP OF FRANKLIN  
O-20-09**

**AMENDING ORDINANCE O-16-07 RESPECTING WEIGHT  
LIMITS ON GRUBB ROAD**

**WHEREAS**, the Township Committee of the Township of Franklin, County of Gloucester and State of New Jersey enacted Ordinance O-16-07, which Ordinance placed weight limitations on vehicles utilizing Grubb Road for its entire length excepting local deliveries; and

**WHEREAS**, said Ordinance was to become effective upon approval by the Commissioner of Transportation; and

**WHEREAS**, the Commissioner of Transportation has asked for clarification in said Ordinance so that the weight restriction for vehicles on Grubb Road be limited to commercial vehicles only; and

**WHEREAS**, The Township Committee is committed to protecting the safety of the citizens of Franklin Township by prohibiting large vehicles from utilizing Grubb Road in accordance with law.

**NOW THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that based upon the recommendations made by the Franklin Township Police Department, Franklin Township Engineer and comments from the New Jersey Commissioner of Transportation, that commercial vehicular traffic shall be limited on Grubb Road to vehicles not exceeding four tons (8,000 pounds) and that commercial vehicles greater than 8,000 pounds shall be prohibited from using Grubb Road for its entire length except for local deliveries; and

**BE IT FURTHER ORDAINED**, that all Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent that they are inconsistent herewith;

**BE IT FURTHER ORDAINED**, that all Ordinances or parts of Ordinances not inconsistent with this Ordinance shall remain in full force and effect.

**BE IT FURTHER ORDAINED**, that this ordinance shall take effect immediately upon its final passage, adoption and publication as provided by law.
