WITHIN THE TOWNSHIP OF FRANKLIN, COUNTY OF GLOUCESTER
PER R-128-16 AND RENEWING THE LICENSE OF MALAGA TAVERN 0805-33-005-003

WHEREAS, certain individuals, corporations and associations have made application to the Township Committee of the Township of Franklin for renewal of plenary retail consumption licenses, club licenses and plenary retail distribution licenses for the period from July 1, 2016 to June 30, 2017; and

WHEREAS, Malaga Tavern was approved by R-128-16 and became inactive. The State of NJ Department of ABC requires the licensee to apply for a Special Ruling which was granted on January 5, 2017.
