**AN ORDINANCE OF THE TOWNSHIP OF FRANKLIN,
COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY
AUTHORIZING ADAMS, REHMANN AND HEGGAN ASSOCIATES, INC.
TO BID FOR THE OVERLAY OF MALAGA LAKE BOULEVARD**

WHEREAS, Franklin Township has been notified that it has been awarded \$45,000.00 for an overlay of Malaga Lake Boulevard from the 2007 Community Development Block Grant (hereinafter referred to as "2007 CDBG"); and

WHEREAS, in order to complete the overlay of Malaga Lake Boulevard, a bid package needs to be prepared so that the Township can bid for the project in accordance with the 2007 CDBG; and

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Franklin, County of Gloucester and State of New Jersey, that the funds received from the 2007 CDBG are to be used to complete the overlay of Malaga Lake Boulevard; and

BE IT FURTHER ORDAINED, that Adams, Rehnmann and Heggan Associates, Inc. (ARH) is hereby authorized to prepare a bid package for the Township to bid for the overlay of Malaga Lake Boulevard in accordance with the 2007 CDBG; and

BE IT FURTHER ORDAINED, that a certified copy of this Ordinance shall be provided to State of New Jersey, Department of Transportation, Commissioner of Transportation for his records; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent that they are inconsistent; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances not inconsistent with this ordinance shall remain in full force and effect; and

This ordinance shall take effect immediately.
