**RESOLUTION DETERMINING THAT CERTAIN ITEMS OF PERSONAL  
PROPERTY OWNED BY OR FORFEITED TO THE TOWNSHIP OF FRANKLIN  
ARE NOT NEEDED FOR PUBLIC USE, AND AUTHORIZING THE SALE OF  
SAID ITEMS AT GOVDEALS.COM**

**WHEREAS**, the Township of Franklin has recently determined that the items of personal property which are set forth in the list annexed to this resolution are not needed for public use; and

**WHEREAS**, the Township of Franklin Committee has further determined that it would be in the best interest of the Township to sell said items of personal property at a public auction website to the highest bidder; and

**WHEREAS**, the Township of Franklin has determined that GovDeals.com is the appropriate auction site to sell said property.

**NOW THEREFORE BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF  
THE TOWNSHIP OF FRANKLIN, COUNT OF GLOUCESTER AS FOLLOWS:**

1. The Township Committee of the Township of Franklin hereby determines that the said personal property described on the attached list, were either forfeited to or purchased by the Township are not needed for public use, and that it is in the public interest that said property.
2. The Township Committee has designated GovDeals.com as the auction site to sell the personal property described on the annexed list for sale to the highest bidder pursuant to Local Finance Notice 2008-9.

4. There is no assurance that any property sold a public auction is fit for any particular purchase and the Township Committee makes no warranties as to the nature or condition of any item of personal property set forth on the annexed list.
5. The Clerk of the Township of Franklin is hereby authorized and directed to publish in the newspaper circulated in the Township of Franklin in accordance with the provisions of N.J.S.A. 40A: 12-13(a), a Notice publishing the items to be sold.
