

**ORDINANCE
TOWNSHIP OF FRANKLIN
AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION
FOR COSTS RELATING TO ADOPTION OF AFFORDABLE HOUSING
PLANS AMENDING THE MASTER PLAN**

O- 32 - 08

WHEREAS, N.J.S.A. 40A:4-53 permits a local unit to adopt an ordinance authorizing a special emergency appropriation for the engagement of special consultants for the preparation of a master plan, when required to conform to the planning laws of the State; and

WHEREAS, the Township of Franklin is desirous of amending their Master Plan in order to adopt Affordable Housing Plans in compliance with State regulations; and

WHEREAS, an amount of \$65,000.00 has been appropriated under N.J.S.A. 40A:4-53 for purposes of amending the Master Plan; and

WHEREAS, such monies shall be taken against the Uncollected Tax Reserve in the Township of Franklin; and

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that in accordance with N.J.S.A. 40A:4-53, a Special Emergency Appropriation is hereby made in the amount of \$65,000.00 for costs relating to the adoption of Affordable Housing Plans amending the Master Plan; and

BE IT FURTHER ORDAINED, that said emergency appropriation shall commence in 2009 at one-fifth (1/5) per year, or \$13,000.00 per year for the next five years; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to such inconsistencies; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances not inconsistent with this ordinance shall remain in full force and effect; and

This ordinance shall take effect thirty (30) days after final passage by Committee or twenty (20) days after approval by the Mayor, whichever comes first.
