

**TOWNSHIP OF FRANKLIN TOWNSHIP

**RESOLUTION APPOINTING AN ENGINEER FOR THE TOWNSHIP OF
FRANKLIN FOR THE YEAR 2017 PURSUANT TO THE LOCAL PUBLIC
CONTRACTS LAW (N.J.S.A. 40A:11-1, ET SEQ.)**

WHEREAS, there exists a need for an Engineer in the Township of Franklin for the purposes of providing the Township Committee of said Township with engineering services and advice; and

WHEREAS, funds are or will be available for this purpose; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires the governing body of a contracting unit to publish a notice in a newspaper authorized by law to publish its legal advertisements, setting forth the nature, duration, service and amount of the contract where such contract is awarded for “professional services” without competitive bidding.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Franklin, County of Gloucester of Gloucester, State of New Jersey, as follows:

1. That the firm of CME Associates is hereby appointed as Engineer for the Township of Franklin to provide engineering services and advice to the officials of said Township for the year 2019.
2. The appropriate officers of the Township of Franklin are hereby authorized to enter into the contract with, for the engineering services above specified, for a term of one year. The fee to be paid to the engineer shall be in accordance the fee schedule on file in the Clerk’s Office.
3. The contract is awarded without competitive bidding as a “professional service” under the provision of the Local Public Contracts Law because the specialized training, education, experience and specialized knowledge needed for this position cannot be properly described in specifications which would have to be prepared for competitive bidding, and because the law permits agreements for professional services without public advertising and bidding.
4. A notice of the award of this contract shall forthwith be printed once in The South Jersey Times, an official newspaper of the Township of Franklin, authorized by law to publish the legal advertisements of the Township Committee of the Township of Franklin, setting forth the nature, duration, service and amount of the contract, and further stating that this resolution and the contract are on file and available for public inspection in the Office of the Clerk of the Township of Franklin.
