

**ORDINANCE**

**AN ORDINANCE OF THE TOWNSHIP OF FRANKLIN  
COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY  
REDUCING THE SPEED LIMIT FROM 50 TO 35 ON BROAD STREET BETWEEN  
DUTCHMILL ROAD AND MORRIS AVENUE IN MALAGA**

**O-06-07**

WHEREAS, the Franklin Township Police Department, has responded to a citizen complaint regarding vehicles speeding on Broad Street in the Malaga section of the Township; and

WHEREAS, the Franklin Township Police Department surveyed the area from Dutch Mill Road to Morris Avenue and has determined that Broad Street satisfies the criteria for a "Suburban Zone" of 35 miles per hour; and

WHEREAS, it is in the best interest of the residents of the Township of Franklin that, the speed limit on Broad Street from Dutch Mill Road to Morris Avenue be reduced from 50 mph to 35 mph based on the findings of the Franklin Township Police Department;

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Franklin, County of Gloucester and State of New Jersey, based on recommendations made by the Franklin Township Police Department, that the speed limit along Broad Street in Malaga from Dutch Mill Road to Morris Avenue for both directions of traffic be and hereby is reduced from 50 mph to 35 mph for the entire length of that section of roadway under the jurisdiction of the Township of Franklin, County of Gloucester, State of New Jersey; and

BE IT FURTHER ORDAINED, that a certified copy of this Ordinance shall be provided to State of New Jersey, Department of Transportation, Commissioner of Transportation; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to such inconsistencies; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances not inconsistent with this ordinance shall remain in full force and effect; and

This ordinance shall take effect thirty (30) days after final passage by Committee or twenty (20) days after approval by the Mayor, whichever comes first.
