

ORDINANCE
TOWNSHIP OF FRANKLIN
AMENDING CHAPTER 373-26, SPEED LIMITS
O-15-07

WHEREAS, Chapter 373-26 of the Code of the Township of Franklin provides for the speed limits on Township Roads; and

WHEREAS, Sergeant Siderio of the Franklin Township Police Department, has reported that the speed limit of Royal Avenue in Franklinville is not currently listed in the Ordinance Book as a road covered by Ordinance No. 373-26; and

WHEREAS, Sergeant Siderio has measured Royal Avenue from Doe Run Road to the bend at Idle Acres Lake and has found that this area contains residential roadway frontage on both sides of the roadway and measures 1,430 feet and therefore meets the requirements for a speed limit of 35 mph; and

WHEREAS, Sergeant Siderio on behalf of the Franklin Township Police Department has recommended that an Ordinance be passed to implement a legal speed limit of 35 mph on Royal Avenue in Franklinville; and

WHEREAS, an Ordinance is required and the Township Committee wishes to amend Chapter 373-26 of the Township Code in order for a speed of 35 mph to be legally enforceable on Royal Avenue;

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, based on recommendations made by the Franklin Township Police Department, Chapter 373-26 of the Code of Franklin Township is hereby amended to reflect that the speed limit on Royal Avenue in Franklinville be legally established as 35 mph; and

BE IT FURTHER ORDAINED, that a certified copy of this Ordinance shall be provided to State of New Jersey, Department of Transportation, Commissioner of Transportation; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to such inconsistencies; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances not inconsistent with this ordinance shall remain in full force and effect; and

This ordinance shall take effect thirty (30) days after final passage by Committee or twenty (20) days after approval by the Mayor, whichever comes first.
