

ORDINANCE

**AN ORDINANCE OF THE TOWNSHIP OF FRANKLIN,
COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY
RESTRICTING THE VEHICULAR WEIGHT LIMIT ON
GRUBB ROAD
O-16-07**

WHEREAS, Franklin Township Citizens have complained about the safety of vehicular traffic particularly involving large trucks requiring larger turning radii while using the intersection of Grubb Road and West Boulevard; and

WHEREAS, the Franklin Township Police Department has also reviewed the matter along with the Township Engineer; and

WHEREAS, the safety of the residents of the Township of Franklin will be better protected by prohibiting large vehicles from using Grubb Road because of the numerous residences between West Boulevard and Delsea Drive; and

WHEREAS, in the opinion of the Township Engineer the safety of the intersection at West Boulevard and Grubb Road can also be improved by prohibiting vehicles with gross weight greater than 4 tons from using Grubb Road;

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Franklin, County of Gloucester and State of New Jersey, based on recommendations made by the Franklin Township Police Department and Township Engineer that the vehicular traffic shall be limited on Grubb Road to vehicles not exceeding 4 tons (8,000 pounds) and that vehicles greater than 8,000 pounds shall be prohibited from using Grubb Road for its entire length except for local deliveries; and

BE IT FURTHER ORDAINED, that a certified copy of this Ordinance shall be provided to State of New Jersey, Department of Transportation, Commissioner of Transportation for his approval prior to enactment; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent that they are inconsistent; and

BE IT FURTHER ORDAINED, all ordinances or parts of ordinances not inconsistent with this ordinance shall remain in full force and effect; and

This ordinance shall take effect immediately after approval by the Commissioner of Transportation.
