

ORDINANCE

TOWNSHIP OF FRANKLIN

0-22-07

AUTHORIZING THE SALE OF CERTAIN UNDERSIZED LAND OWNED
BY THE TOWNSHIP OF FRANKLIN

WHEREAS, the Township of Franklin is the owner of certain undersized land identified as Block 5210 Lot 2 on the Tax Assessment Map of Franklin Township; and

WHEREAS, said property is not needed for public use by the Township of Franklin; and

WHEREAS, the Township Committee is desirous of selling said property at private sale to contiguous property owners, pursuant to N.J.S.A. 40A:12-13(b), subject to the land being sold as a single parcel, and subject to the highest bid and subject to a minimum bid of one thousand eight hundred dollars (\$1,800.00) and any conditions as hereinafter set forth; and

WHEREAS, the property is sold "as is, where is" and the Township does not make any representations as to the property;

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that Block 5210 Lot 2 owned by the Township is not needed for public use and shall be sold to a contiguous landowner by sealed bid; and

BE IT FURTHER ORDAINED, all bids must be received by the Township Clerk's Office prior to 1:00 P.M. on Friday, November 30, 2007, at which time all bids will be opened; and

BE IT FURTHER ORDAINED, that each bidder is required to submit a deposit at the time of the bid of 10% of their bid, by cash or check; money order, or cashier's check; and

BE IT FURTHER ORDAINED, the balance of the purchase price for the above property shall be paid to the Township Clerk by cash or certified check; money order, or cashier's check on or before 10:00 a.m. on Wednesday December 12, 2007; and

BE IT FURTHER ORDAINED, in the event the successful bidder fails to pay the balance of the purchase price within the time specified, the Township Committee reserves the right to cancel the sale and retain the deposit as liquidated damages and sell the property to the next highest bidder under the same terms and conditions; and

BE IT FURTHER ORDAINED, that the proper officials of the Township Committee are authorized to execute documents to complete such sale; and

BE IT FURTHER ORDAINED, the Township Committee reserves the right to reject any and all bids.
