

TOWNSHIP OF FRANKLIN

**RESOLUTION AUTHORIZING THE APPROVAL OF BUS STOPS
WITHIN THE TOWNSHIP OF FRANKLIN**

R- 129-19

WHEREAS, the Governing Body of the Township of Franklin has been asked for bus stops within the Township of Franklin for the residents' benefit; and

WHEREAS, it appears to be in the best interest of the residents of the Township of Franklin and those who use the roads in Franklin Township to allow for this stop. Whereas the State of NJ Department of Transportation has recommended the repeal of certain stops which are inconsistent with the approval of the following stops:

Bus Stops:

Along Route NJ 47, northbound, on the easterly side at:

- A. Marshall Mill Road – (far side) (NJ Transit ID # 19699)
Beginning at the northerly curb line of Marshall Mill Road and extending 100 feet northerly therefrom.**
- B. Between Marshall Mill Road and Nelson Avenue – (mid-block) (NJ Transit ID# pending)
Beginning at a point 1555 feet north of the northerly curb line of Marshall Mill Road and extending 135 feet northerly therefrom.**
- C. Between Nothnick Lane and Pennsylvania Avenue – (mid-block) (NJ Transit ID# 19700)
Beginning at a point 3025 feet north of the northerly curb line of Nothnick Lane and extending 135 feet northerly therefrom.**
- D. Between Williamstown Road (CR 612) and Elmer Street – (mid-block) (NJ Transit ID# 19701)
Beginning at a point 1310 feet north of the northerly curb line of Williamstown Road (CR 612) and extending 135 feet northerly therefrom.**
- E. Between Veterans Way (CR 657) and Coles Mill Road (CR 538) – (mid-block) (NJ Transit ID# 19702)
Beginning at a point 205 feet north of the northerly curb line of Veterans Way (CR 657) and extending 135 feet northerly therefrom.**

Along Route NJ 47, southbound, on the easterly side at:

**Between Coles Mill Road (CR 538) and Veterans Way (CR 657) – (mid-block) (NJ Transit ID# 19703)
Beginning at a point 245 feet south of the southerly curb line of Coles Mill Road (CR 538) and extending 135 feet southerly therefrom.**

**Between Elmer Street and Williamstown Road (CR 612) – (mid-block) (NJ Transit ID# 19704)
Beginning at a point 100 south of the southerly curb line of Elmer Street and extending 135 feet southerly therefrom.**

**Pennsylvania Avenue – (far side) (NJ Transit ID# 19705)
Beginning at the southerly curb line of Pennsylvania Avenue and extending 100 feet southerly therefrom.**

**Between Nelson Avenue and Marshall Mill Road – (mid-block) (NJ Transit ID# pending)
Beginning at a point 1190 feet south of the southerly curb line of Nelson Avenue and extending 135 feet southerly therefrom.**

**Marshall Mill Road – (near side) (NJ Transit ID# 19706)
Beginning at the northerly curb line of Marshall Mill Road and extending 105 feet northerly therefrom.**

Repealer Clause:

The Township of Franklin concurs that any approved bus stop locations or traffic regulations in conflict with or inconsistent with the provisions of this resolution be rescinded upon approval of the Traffic Regulation Order.

NOW THEREFORE, BE IT RESOLVED, by the Township of Franklin, Committee of the Township of Franklin, County of Gloucester, State of New Jersey that the bus stops are approved.

ADOPTED, at a regular meeting of the Township Committee of the Township of Franklin on September 24, 2019.
