ORDINANCE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF GLOUCESTER, AND STATE OF NEW JERSEY, ENACTING AND ADOPTING PERSONNEL POLICIES, CHAPTER 92, Article 92-7 OF THE CODE OF THE TOWNSHIP OF FRANKLIN ENTITLED, "GENERAL POLICIES AND PROCEDURES"

WHEREAS, Chapter 92 of the Code of the Township of Franklin, entitled, "Personnel Policies" contains previously adopted Personnel Policies and Practices for the employees of the Township of Franklin; and

WHEREAS, the Township of Franklin has reviewed the personnel policies and practices and wishes to make changes that would enact Controlled Substances and Alcohol Use and Testing Policies to reflect current administrative, legal and insurance requirements; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Franklin, County of Gloucester and State of New Jersey as follows:

SECTION 1: Chapter 92-7 to be entitled, "Controlled Substances and Alcohol Use and Testing Policies", is hereby enacted and to be read as follows: "The Controlled Substances and Alcohol Use and Testing Policies," dated January 1, 2020 is adopted and shall be kept on file in the office of the Business Administrator. The Controlled Substances and Alcohol Use and Testing Policies shall be available to any full or part time employee to read and all full or part time employees shall be expected to adhere to its policies and procedures.

SECTION 2: All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance..

SECTION 4: Upon adoption of this Ordinance after public hearing thereon, the Township Clerk is further directed to publish notice of the passage thereof and to file a copy of this Ordinance with the Township Clerk and any other agencies as required by law.

SECTION 5: This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
