**RESOLUTION REQUESTING THE DIRECTOR OF THE DIVISION OF LOCAL  
GOVERNMENT SERVICES TO AUTHORIZE THE INSERTION OF A SPECIAL  
ITEM OF REVENUE IN THE 2021 BUDGET OF THE  
TOWNSHIP OF FRANKLIN, COUNTY OF GLOUCESTER,  
STATE OF NEW JERSEY**

**WHEREAS**, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been available by law and the amount thereof was not determined at the time of the adoption of the budget; and

**WHEREAS**, said Director may also approve the insertion of an item of appropriation for an equal amount; and

**WHEREAS**, the Township of Franklin wishes to amend its 2021 Budget to include the SFY21 Body-Worn Camera Grant Program from the New Jersey Department of Law and Public Safety in the amount of \$77,444.00 for the purchase of Body-Worn Cameras for the Franklin Township Police Department; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Township Committee of the Township of Franklin, in the County of Gloucester, New Jersey, hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue from the following items in the 2021 Franklin Township Budget:

3. Miscellaneous Revenues – Section f: Special Items of General Revenue Anticipated with Prior Written Consent of Director of Local Government Services – Public and Private Revenues offset with appropriations:
