AWARDING THE CONTRACT FOR BODY-WORN TO COBAN TECHNOLOGIES, INC. / SAFE FLEET LAW ENFORCEMENT

WHEREAS, on July 22, 2021, the State of New Jersey, Department of Law & Public Safety, Office of the Attorney General (OAG), issued Award Number 21-BWC-155, in the amount of \$77,444.00, for the period of January 1, 2021, thru December 31, 2025, from State Account No. BFY21-100-066-1020-495 to the Township of Franklin for the SFY21 Body-Worn Camera Grant Program; and

WHEREAS, Coban Technologies, Inc. / Safe Fleet Law Enforcement, with a mailing address of 11375 West Sam Houston Parkway South – Ste 800, Houston, Texas 77031-2348, has submitted proposal Q-16765-7 dated April 5, 2021, in the amount of \$94,907.35, to supply Body-Worn Cameras to the Franklin Township Police Department as described in Exhibit A, attached hereto; and

WHEREAS, the Police Chief of the Township of Franklin and the Township Committee have reviewed the proposal; and

WHEREAS, it is the intention of the Township of Franklin to enter into a Contract with Coban Technologies, Inc. / Safe Fleet Law Enforcement under the terms and conditions in the April 5, 2021, proposal with a cost not to exceed \$94,907.35; and

WHEREAS, the CFO has certified the availability of funds in the amount of \$94,907.35 per CAF (Attached hereto as Exhibit “B”), which shall be charged against budget line item numbers G-02-05-600-005 in the amount of \$77,444.00 and 01-25-240-294, in the amount not to exceed \$17,463.35.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Committee of the Township of Franklin, County of Gloucester in the State of New Jersey, as follows:

- 1. Coban Technologies, Inc. / Safe Fleet Law Enforcement’s April 5, 2021, proposal for Body-Worn Cameras to the Franklin Township Police Department is approved.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Mayor and Clerk of the Township of Franklin, Gloucester County, New Jersey, are hereby authorized and directed to execute any documents necessary to effectuate the April 5, 2021, proposal.
