**RESOLUTION AUTHORIZING THE TAX COLLECTOR AND CHIEF FINANCIAL OFFICER TO GRANT TAX EXEMPTION FOR A TOTALLY DISABLED VETERAN**

**WHEREAS**, upon the printing of the Tax Duplicate, the property knowns as Block 301 Lot 1.02 listed as Property Class 2 and taxes were assessed, and
