**RESOLUTION APPOINTING SPECIAL COUNSEL  
FOR BOND SERVICES**

**WHEREAS**, there exists a need for the retention of special counsel having an expertise in the complex subject area of Bond Ordinances for the purpose of providing the Township Committee with legal services on general public finance matters for the Township of Franklin to meet its short and long term obligations for Bond and/or Note Ordinances under New Jersey law; and

**WHEREAS**, funds are or will be available for this purpose; and

**WHEREAS**, the Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. requires the governing body of a contracting unit to publish a notice in a newspaper authorized by law to publish its legal advertisements, setting forth the nature, duration, service and amount of the contract where such contract is awarded for “professional services”.

**NOW, THEREFORE BE IT RESOLVED**, by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, that Timothy Cunningham of Archer & Greiner PC, be and is hereby appointed as Special “Bond Services” Counsel to provide representation, advice, reports and related legal services regarding the issuance of Bond and/or Note Ordinances to the Township Committee for the year 2022 in accordance with the attached Contract.

**AND BE IT FURTHER RESOLVED** that the appropriate officers of the Township of Franklin are hereby authorized to enter into the attached contract with for services specified above until December 31, 2022.

**AND BE IT FURTHER RESOLVED** that said contract is awarded as a “professional service” under the provision of the Local Public Contracts Law because of the specialized training, education, experience and specialized knowledge needed for this position.

**AND BE IT FINALLY RESOLVED**, that a copy of this resolution be forwarded to The Sentinel, an official newspaper of the Township of Franklin, authorized by law to publish the legal notices of the Township Committee of the Township of Franklin, and further stating that this resolution and the annexed contract are on file and available for public inspection in the office of the Clerk of the Township of Franklin.

**AGREEMENT BETWEEN THE  
TOWNSHIP OF FRANKLIN AND TIMOTHY CUNNINGHAM OF ARCHER  
& GREINER, PC**

**WHEREAS**, the Township of Franklin, hereinafter referred to as "Township", requires the services of Special Counsel for Bond Services for the calendar year 2022, commencing January 1, 2022; and

**WHEREAS**, Timothy Cunningham of Archer & Greiner PC, hereinafter referred to as "Special Legal Counsel for Bond Services" is a licensed attorney in the State of New Jersey, and has agreed to accept the appointment of the Township for the performance of the duties of attorney subject to the following terms and conditions:

**WITNESSETH:**

1. Timothy Cunningham of Archer & Greiner PC shall be appointed to represent the Township for a term of one (1) year, commencing January 1, 2022, and they shall perform all duties required of a local representative of the Township.

2. During the term of this Agreement, the Special Legal Counsel for Bond Services shall devote their best efforts to advance the interest of the Township; they shall perform their duties to the best of their ability and in accordance with the Code of Professional Ethics by the New Jersey Supreme Court.

3. The Special Legal Counsel for Bond Services shall receive a salary as set forth on the Cost Proposal.
